
- a) Awards for Manufacturing Entrepreneurship – Technologically Efficient Manufacturing Enterprises

- e) Awards for Women Entrepreneurship – Small Enterprises (Services)
- f) Awards for Entrepreneurs belonging to SC/ST Category – Small Enterprises (Manufacturing)
- g) Awards for Entrepreneurs belonging to SC/ST Category – Micro Enterprises (Services)
- h) Awards for Entrepreneurs belonging to SC/ST Category – Small Enterprises (Services)
- i) Awards for Entrepreneurs belonging to “Divyang” Category – Manufacturing Enterprises
- j) Awards for Entrepreneurs belonging to “Divyang” Category – Service Enterprises
- k) Awards for Entrepreneurs belonging to States of NER – Micro Enterprises (Manufacturing)
- l) Awards for Entrepreneurs belonging to States of NER – Small Enterprises (Manufacturing)
- m) Awards for Entrepreneurs belonging to States of NER – Micro Enterprises (Services)
